Category I Internal and School-Based Organizations

This category is defined as all school-organized programs that involve co-curricular or extracurricular activities, as well as Town-sponsored activities. These activities are either (i) supervised and/or coordinated by the Lincoln Public Schools employee(s) and sanctioned by the Lincoln Public Schools (i.e. PTA/PTO, Student Council, Athletic Teams); or (ii) coordinated/approved by the Town of Lincoln. The Town of Lincoln Administrator shall provide a list to the Superintendent of the Lincoln Public Schools identifying all programs the Town of Lincoln determines belong in Category I. Such list may be edited by the Town of Lincoln Administrator as he or she sees fit, and shall be reviewed and accepted by the Superintendent in his or her sole discretion. Please see attached list for reference purposes, which list may be amended from time to time.

Category II Local Non-Profit Organizations

This category is defined as any Lincoln organization that is governed by a board and by-laws and possessing a 501(c) Tax Exempt Certificate. Groups claiming Non-profit status will be required to provide documentation verifying their status each time the group submits a request.

Category III Businesses and Organizations inside Town Limits

This category is defined as any incorporated business and organization, located within the Town of Lincoln limits.

Category IV Businesses and Organizations outside Town Limits

This category is defined as any incorporated/organized business or Non-Profit organization located outside the Town of Lincoln. Information/documentation is required to show tax-exempt and /or corporate status.
